- b) As for 85299041, 85299042, 85299049, 85299050, 85299060, 85299081, 85299082 and 90221200, customs duties shall be eliminated through equal annual reductions beginning on 1st July of 2018.
- c) As for 90181300, 90318010, 90318020 and 90318090, customs duties shall be eliminated through equal annual reductions beginning on 1st July of 2019.
- d) Other duties and charges of any kind, within the meaning of Article II:1(b) of the GATT 1994, shall be eliminated by 1 July 2016.
