CUSTOMS DUTIES (GOODS UNDER THE FRAMEWORK AGREEMENT ON COMPREHENSIVE ECONOMIC CO-OPERATION AMONG THE GOVERNMENT OF THE MEMBER COUNTRIES OF THE ASSOCIATION OF SOUTHEAST ASIAN NATIONS AND THE REPUBLIC OF KOREA) (AMENDMENT) (NO. 2) ORDER 2011

IN exercise of the powers conferred by subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Goods under the Framework Agreement on Comprehensive Economic Co-operation among the Government of the Member Countries of The Association of Southeast Asian Nations and The Republic of Korea) Order 2007 (Amendment) (No. 2) Order 2011**.

(2) This Order comes into operation on 1 January 2012.

Amendment of paragraph 3

2. The Customs Duties (Goods under the Framework Agreement on Comprehensive Economic Co-operation among the Government of the Member Countries of The Association of Southeast Asian Nations and The Republic of Korea) Order 2007 [*P.U. (A) 209/2007*], which is referred to as the “Principal Order” in this Order, is amended—

- (a) in subparagraph 3(1), by inserting after the words “in the Second Schedule”, wherever it appears, the words “and the Fourth Schedule”;
- (b) in subparagraph 3(2), by inserting after the words “in the Second Schedule” the words “and the Fourth Schedule”;

(c) in subparagraph 3(4), by inserting after the words “in the Second Schedule or the Third Schedule” the words “or the Fourth Schedule”; and

(d) by inserting after subparagraph 3(4) the following subparagraph:

“(5) In the case of those goods subject to the tariff rate quota as specified in column (4) of the Fourth Schedule, import duty shall be levied at specified rates in Appendix A, subject to the quota as determined by the agency in column (5)”;

Amendment of paragraph 4

3. Paragraph 4 of the Principal Order is amended in the shoulder note by inserting after the words “in the Second Schedule” the words “and the Fourth Schedule”.

Amendment of paragraph 5

4. Paragraph 5 of the Principal Order is amended by inserting after the words “in the Second Schedule” the words “and the Fourth Schedule”.
