Your Excellency,

I have the honour to refer to our discussions in relation to entry into New Zealand of Korean primary sector trainees.

Based on these discussions, I further have the honour to confirm that the Government of New Zealand will take the following measures from the same day as the *Free Trade Agreement between the Republic of Korea and New Zealand* enters into force:

1. New Zealand will each year allow up to fifty (50) eligible nationals of the Republic of Korea to be issued with primary sector training visas to undertake a combination of study and work in New Zealand for up to a maximum of twelve (12) months.
2. New Zealand will not require labour market testing, economic needs testing or other procedures of similar effect in issuing primary sector training visas.
3. The vocational training could cover all primary sectors with the exception of forestry. The trainees must be supported by the Government of the Republic of Korea.
4. The trainees:
  - must study in New Zealand for a minimum of twelve (12) weeks with a high quality education provider (universities or a provider assessed as category one by the New Zealand Qualifications Authority);
  - can undertake work placements, related to their study and up to a maximum of nine (9) months' duration, that are arranged and monitored by the education provider;
  - must have New Zealand employment agreements, and must be paid at least the New Zealand minimum wage (the education provider will be responsible for ensuring employers comply);
  - would not be able to apply for a further work visa in New Zealand for two (2) years; and
  - must fulfil all other immigration requirements, including health and character requirements.

5. Either the Republic of Korea or New Zealand may, at any time, through the diplomatic channel request consultations on any issues arising from the primary sector training visas. The Republic of Korea and New Zealand will enter into consultations within thirty (30) days of the request.
