

**(Turkey's Proposing Note)**

Ankara, 1 February 2018

Excellency,

I have the honour to refer to the Agreement on Trade in Services under the Framework Agreement Establishing a Free Trade Area between the Republic of Korea and the Republic of Turkey, signed at Seoul on 26th February 2015 (hereinafter referred to as the "Agreement").

I have also the honour to propose, on behalf of the Government of the Republic of Turkey that the Second Section of Annex D, "Schedule of Specific Commitments - Republic of Turkey" of the Agreement be adjusted as follows:

- A. The Mode 4 commitment on Limitations on Market Access regarding Accounting, auditing and bookkeeping services (CPC 862) shall be "Unbound", as in the Adjusted Schedule attached hereto.
- B. The Mode 4 commitments on Limitations on Market Access and Limitations on National Treatment regarding Veterinary Services (CPC 932), Postal Services (CPC 7511) and Hospital Services (CPC 9311) shall be "Unbound", as in the Adjusted Schedule attached hereto.

If the above proposal is acceptable to the Government of the Republic of Korea, I have the honour to propose that this Note, together with the Adjusted Schedule, and Your Excellency's Note in reply indicating acceptance, shall constitute an agreement between our two Governments, which shall enter into force on the date of the entry into force of the Agreement.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
